Meeting Minutes

November 11th, 2023

Present today was Terry Smith, Teddy Udala, Karen Keene, Medy Medel, Ralph Johnson, Ken Clapsaddle, Jim Thurow, Jim Miskiak, Dave Bacon, Jordon Felder & Shawn Hart. On Zoom was David Khoe and Barry Rechtorovich.

We actually made a small profit on the Fly-in this year! Even with the Lake closed, Karen was able to let us know we made a small profit of \$351.63 - which is a Fantastic outcome! The event was a great success!

Over the last 2 year, we've had to host the Fly-In on the West Side of Gyro Cove, and both years there have been better for everyone to drive there via the perimeter road around the Lake, and on this side, the wind has not been ass problematic. Also, when the wind did pick up, we did not get a lot of dirt blown on us as the scrub bushes behind us helped keep any dust down.

A vote was taken at the meeting to gauge the idea that the Fly-In location be permanently relocated to this spot, and members at the meeting all felt this was a positive idea. This suggestion will be emailed out to all members to get their vote on this.



Jim Misiak asked whether or not the BLM had any concerns about Chapter One using the Lake for the event, and we've always had a good relationship with them. We police the area and clean up all the trash, and make sure everyone has their Lake Pass.
